IMPORTANT: You must list ALL your <u>debts</u>. If in doubt about a creditor, list them. Your creditors must have notice of the bankruptcy petition for the debt to be discharged. Anyone you owe money to is a creditor - including family and friends. Even if you plan to repay your family and friends you still must list them. List all disputed debts as well. List all potential debts to those people who have not yet brought a claim against you.
